<p>On 8/16/2015 I was on patrol when I observed a grey Honda Accord failure to signal & disregard the stop sign at Lowes Dr. & N.16th St. I initiated my emergency equipment stopping the vehicle in the parking lot of FiveStar Fuel. The driver Ezekiel P. Pike had a strong odor of an alcoholic beverage & marijuana coming from about his person/vehicle. Pike had an open Bud Light Beer within his reach & was asked out of the vehicle, Pike stated he had a marijuana pipe in his right shorts pocket that didn't belong to him. Pike stated he only had a few alcoholic drinks earlier this date. SFST's administered, OLS - put foot down twice, W&T - stepped off line - missed heel to toe on second set of 9 steps twice, HGN - received 6 clues. Pike was transported to MCH for blood draw. While escorting Pike, Pike escaped my custody and fled 350 yards on foot before being apprehended. Pike was tasered due to non-compliance with loud verbal commands during pursuit. Implied consent read verbatim. Pike REFUSED blood.</p>
